4.2 ANA Standard Code Lists: Book Trade Subsets

The following subsets of ANA TRADACOMS standard code lists are recommended by BIC for use in book trade EDI messages.

ANA List 1 – Transmission priority code

Optional in STX for all types of transmission.

Note that this represents a *transmission* priority, not a message or message file priority. Standard EDI translators may not pass this information to an application system when interpreting an incoming message. Where there is a need to identify an individual message as requiring priority treatment, this must be done as part of the message (see ANA List 6 and Section 2, BIC List 201).

ANA List 3 – Transaction type

Because TTYP is optional in all message headers, and simply confirms mnemonically the information coded in TYP TCDE (ANA List 2), new message types are not now given a TTYP value. BIC recommends that new implementations should NOT include TTYP in outgoing messages. However, users must be aware that it may be present in incoming messages. For a list of code values, see the *Tradacoms Manual*, Syntax and Data Dictionary, ANA Standard Code Values List 3.

ANA List 4 – Measure indicator

Optional in DELIVR (DLD)

The Measure Indicator sub-element may appear in many other contexts and with many other values, but to date the only use made in book trade practice is for the total weight of a delivered line in a Delivery Notification. See the *Tradacoms Manual*, Syntax and Data Dictionary, ANA Standard Code Values List 4.

ANA List 5 – Special price indicator

Optional in ORDERS and BTOERS (OLD), and in INVOIC (ILD). Appears in DELIVR (DLS), but not used in book trade practice.

This usage should not be confused with specific promotional deals agreed between trading partners and identified in the order by a promotion reference in SCRF.

ANA List 7– Order code

Optional in ORDERS and BTOERS (OLD). Because ORCD is optional, and repeats the information coded in TYP TCDE, BIC recommends that it should be omitted. However, users must be aware that it may be present in incoming messages. For a list of code values, see the *Tradacoms Manual*, Syntax and Data Dictionary, ANA Standard Code Values List 7.

ANA List 8 – To follow indicator

Optional in ORDERS and BTOERS (OLD). EDI trading agreements should determine whether dues are recorded, and OLD TFIN should be used only to indicate an exception. Appears in DELIVR (DLS), but not used in book trade practice.

268	Unique copy ID. Assigned by a library acquisitions computer system to identify a single copy of a book or other publication: different from the accession or barcode number. (See also code 067.)
269	Shelf mark, or spine label. The complete string of codes applied on the spine of a book or other publication to specify its shelf location within a library. Do not use if the individual components (e.g., 068, 271) are sent separately.
270	Shelving sequence. A code or abbreviation which identifies the shelving sequence to which a book or other publication belongs in a library, e.g., "local history collection" or "large print books". Hence normally the first element in the shelf mark.
271	Filing suffix. An extension to the classification (068) of an individual copy of a book or other publication in a library, used for shelving within a shelving sequence and classification.
272	Feature heading. An extension to the classification (068) of an individual copy of a book or other publication in a library, used to clarify the content or as an additional shelving element.
273	Size code. A code which specifies a size group or range for a specific application (e.g., quarto for books).
274	Branch or location code. A code indicating the location (e.g., a library branch) to which an item (e.g., a copy of a book or other publication) is allocated. NOT necessarily the delivery location.
275	Replacement value. A monetary amount reckoned to be the replacement value of an item (e.g., a copy of a book or other publication) and used to assess charges for loss or damage. Format: 9(10)V9(2)

279	Consolidated invoice reference number. Used to allow reference forward from provisional invoices sent by EDI to a periodic consolidated tax invoice sent as a paper document (library supply only).
288	Seller's quotation line reference. Used to carry a reference at line level to a unique line reference in a supplier's quotation (e.g. when a TRADACOMS order refers back to an EDIFACT QUOTES message). Format: X(35)
295	Catalogue or price list reference. A reference to a supplier's catalogue or price list, from which the product information used in an order was derived. May be used, for example, in orders based on information downloaded from a library supplier's CD-ROM. Format: X(35)

Introduction: TRADACOMS code list 54 serves multiple purposes: it is used in the TRADACOMS PVUINF P&A feed supplied by most UK distributors to data aggregators and others; it is used for order acknowledgments; and it is the basis for proprietary acknowledgment code lists used by wholesalers and others. If there is a standard 'BIC order response code list', this is it. It is within BIC's remit to modify, remodel or extend List 54.

Availability Status Codes: P&A feeds from Distributors

There are millions of price and availability updates made to physical books in the UK every year, yet booksellers, self-distributed publishers, distributors and wholesalers all cite price and availability (P&A) information as a common cause of queries.

Unambiguous and actionable price & availability information at ISBN level is important. This is the purpose of BIC's Code List 54. In this update, several codes have been deprecated to remove ambiguity and confusion. The notes on the application and the interpretation of the remaining codes have also been reviewed for clarity and understanding. But Code List 54 is more than a means of showing the price & availability status of discoverable book products. It's critically important for order management too (see page 11 onwards). In the supply chain, every book ordered should be acknowledged and Code List 54 includes a set of availability status codes just for this purpose.

Our guiding principle has been to reflect the needs of industry stakeholders (senders and recipients of metadata as well as those with a need for transactional data). In a supply chain that is increasingly automated, these price & availability status codes provide clear, useful and actionable information. Not only does this enhance efficiency and responsiveness, but reduces the scope for errors, delays and the need for manual intervention.

All newly deprecated availability status codes are shown in a separate, shaded table. These are codes considered to be obsolete, confusing or duplications of other codes that remain in the active list. Bookseller, self-distributed-publisher, distributor and wholesaler systems should be updated to remove deprecated codes from use. The continued use of deprecated codes will lead to further confusion. Moreover, the use of bespoke or in house codes that are unique to one business or trading relationship should be avoided. These codes will be meaningless to the majority of book industry organisations and are a source of further confusion.

Availability Status Codes: Order Acknowledgements

An order acknowledgement is a message that is sent by the book distributor, self-distributed publisher or wholesaler on receipt of an order for a title in its inventory. The order acknowledgement and the concomitant status code are sent to the organisation that originally placed the order. They not only confirm receipt of the order but also the status of the ISBN, helping businesses make informed order management decisions.

If the availability status of an ISBN changes after the initial order acknowledgement is sent, then a reacknowledgement is required. This process should be repeated as often as is needed to reflect the changing status of the ISBN until the order line is fulfilled.

Whilst the table column headings overleaf should be self-explanatory, it is worth remembering that the nuances of certain order acknowledgement codes will mean that one code may be more suitable than another, depending on the situation. Please refer to 'Notes on Application' and 'Consider Also' columns for more guidance.

Order acknowledgements in and of themselves will not help in the proactive management of orders. Look at 'Recipient's Interpretation' for guidance on how to action or respond to a specific order acknowledgement code. A small number of codes do require prior agreement between the trading parties (refer to the last column) before they can be used.

All deprecated order acknowledgement codes are shown in the shaded table. Bookseller, self-distributed-publisher, distributor and wholesaler systems should be updated to remove these codes from active use. The continued use of deprecated codes will lead to confusion. Moreover, the use of bespoke or in house codes that are unique to one business or trading relationship should be avoided. These codes will be meaningless to the majority of book industry organisations and are a source of further confusion.

DNAC

Order action codes are fixed length (two digit) codes. They are used in conjunction with order acknowledgement codes (see TRADACOMS Code List 54) by distributors, self-distributed publishers, wholesalers and library suppliers to inform their trading partners (booksellers, e-tailers, libraries) of the current status of individual order lines.

Although the current list is extensive, the original list (unshaded lines on pages 41 - 45) was relatively short and reflected those codes published in pre - 1999 versions of the code list, which are part of ANA published lists.

Since 1999 the list has incorporated additional codes, included to offer consistency with EDItEUR Order Action Codes (EDItEUR Book Trade List 12b: Order Action/ Status Code). These codes are easily identified by shading in the table on pages 49 – 51. The additional codes are primarily intended for wholesaler and library supplier use rather than the general trade.

We have split these codes into separate lists on pages 46 - 51 for ease of reference and expanded the information on code application and interpretation to reflect the style and conventions used in Code List 54. This is a work in progress. The two code lists go hand in hand.

Code 10 (Order line not on backorder file) is newly deprecated in favour of two more relevant codes – Code 08 (Order line already despatched or in process) and Code 09 (Cannot trace order line).

Code 70 has been added to signify a 'soft reject'. This indicates that the supplier will not supply the line, but that the retailer may reorder in the future.

Reason code (02) is updated to give a more precise definition of a 'hard reject', meaning 'Order line not accepted – do not try to reorder', typically used for out of print or divested products.

The order acknowledgement (Code List 54) and the concomitant order action code (Code List 55) are sent to the organisation that originally placed the order. They not only confirm receipt of the order but also the status of the ISBN, helping businesses make informed order management decisions. The order action code enhances the power of the order acknowledgement by providing further information to help determine the next step in the order management process. For example:

An order acknowledgement code 'OF' ('This format out of print, other manifestation available') will on its own require bookseller intervention to inform next steps.

However, including an appropriate order action code will mean that the next step is expedited in a more efficient and timely manner. In the case of 'OF', several possible responses are available:



'04' will mean a substitute product will be supplied

'05' requires confirmation that the substitute product will be accepted

'02' where substitutions are not accepted, the order line will be cancelled.

Note that there will be very few instances where an order acknowledgement code should not be accompanied by an order response code.

BIC List 206 – BIC message version number

Used in all messages in DNA DNAC in the message file header, to indicate the version number of the BIC message which is being sent. There is therefore no code list as such: the version number is taken from the BIC Implementation Guidelines which are being used.

The version number is a fixed-length three-character code. The first character is either "T" for trade or "L" for library. The last two characters are a two-digit number, e.g., T02.

Example: DNA=1+206:T04'

BIC List 207 – BIC code list version number

Used in all messages in DNA DNAC in the message file header, to indicate the version number of the BIC Code Lists which are being used. The version number is taken from the cover or first page of the BIC Code Lists.

The version number is a fixed-length three-digit number, e.g., 008 if the present issue of the BIC Code Lists has been implemented.

Example: DNA=1+207:008'
