Metadata and Classification

The efficiency and smooth-running of the book industry depends on the **accurate** and **timely** sharing of data between organisations.

Organisations can go a long way towards achieving this by streamlining and standardising their processes through using and promoting **best practice** and **industry recognised and approved standards**. BIC, in association with partner organisations such as **EDITEUR**, aims to support this through a number of projects, schemes and training.

METADATA CAPABILITIES DIRECTORY (MCD)

The MCD is a vital new **free** facility provided by BIC that enables supply chain partners to share key metadata activity with each other.

The Directory is a secure database of survey responses from a wide range of organisations and by contributing to it participants are able to **benchmark their own actions** and **identify potential improvements** to their metadata systems and processes. It aims to represent actual **metadata behaviours** within the data supply chain, allowing contributors to update their information as and when data activities change.

BIC member organisations (only) are able to access the full MCD database for free after making their own contribution to it by completing a **comprehensive metadata survey**.



THEMA

PROJECTS



Thema is a multilingual subject category scheme designed for organisations in all sectors of the global book industry. It enhances merchandising, discoverability and potential sales of books by simplifying the communication of accurate and detailed subject information across international markets.

At the end of February 2024, *Thema* will replace the outdated BIC Standard Subject Categories scheme (BSSC). For more details see our most recent <u>press release</u>.

Thema is developed and managed by **EDITEUR** (the organisation that also develops ONIX), with guidance from an international committee of representatives from more than **15 countries** including the USA, UK, Canada and many European countries. Groups in Japan, China, Korea, Australia and Latin America are also involved.

BIC runs the <u>UK Thema National Group</u>, which feeds directly into the International *Thema* Steering Committee which meets at London and Frankfurt Book Fairs every year.

OUT OF PRINT



This project was charged with agreeing, documenting and promoting best practice for the treatment of **out of print (OP)** products for all organisations in the book industry.

The resulting <u>Out of Print Best Practice Guidelines</u> cover all areas of the supply chain (physical and digital). As such the guidelines include best practice across the industry for <u>publishers</u>, <u>data aggregators</u>, <u>retailers</u>, <u>service providers</u>, <u>distributors</u> and so on.



PROJECTS

UK STANDARD LIBRARY CATEGORIES (UKSLC)

This scheme is designed for the public library sector to provide **library-oriented category headings** applicable across the full range of adult non-fiction, fiction and children's/young adult stock.

Adoption of a scheme of *Thema*-based standard subject/genre categories, made available to libraries in addition to **existing Dewey classifications**, offers the opportunity to **reduce cost** and **streamline workflows** by automating the categorisation process, and to support further improvements in **stock selection**, **management**, **discovery** and **display**.

BIC runs the **UK ONIX National Group**, which feeds directly into the International ONIX Steering Committee, meeting at the London and Frankfurt Book Fairs every year.

MEA accreditation

BIC's Metadata Excellence Award (MEA) scheme is designed to encourage publishers to appreciate the contribution made by **accurate** and **timely** product data to their **sales**; to enable them to demonstrate their commitment to making that **data available in the supply chain**; and to enable them to **benchmark their performance** against their competitors.

It's open to **BIC members and non-members alike**, with four application deadlines spread across the year.
